MOVEABLE FEAST PREPARED AND DELIVERED 421,991 MEALS TO 1,973 CLIENTS IN 2023. MEALS ARE DELIVERED WEEKLY TO CLIENTS LIVING IN BALTIMORE CITY AND THE FOLLOWING 14 COUNTIES: ANNE ARUNDEL, BALTIMORE, CAROLINE, CARROLL, CECIL, DORCHESTER, HARFORD, HOWARD, KENT, QUEEN ANNE'S, SOMERSET, TALBOT, WICOMICO, AND WORCESTER.
